INTRODUCTION

Management Development Training on Prevention of Sexual Harassment

“Equality of status and opportunity” must be secured for all citizens. Equality of every person under the law is guaranteed by Article 14 of the Constitution.”

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act was passed in 2013. The Act defines sexual harassment and makes it the duty of all employers to prevent it at their workplaces. Its far-reaching provisions are stringent and mandate the setting up of a forum —Internal Committee—where working women may file complaints and get redress. It also provides for penalties that may be imposed against offenders.

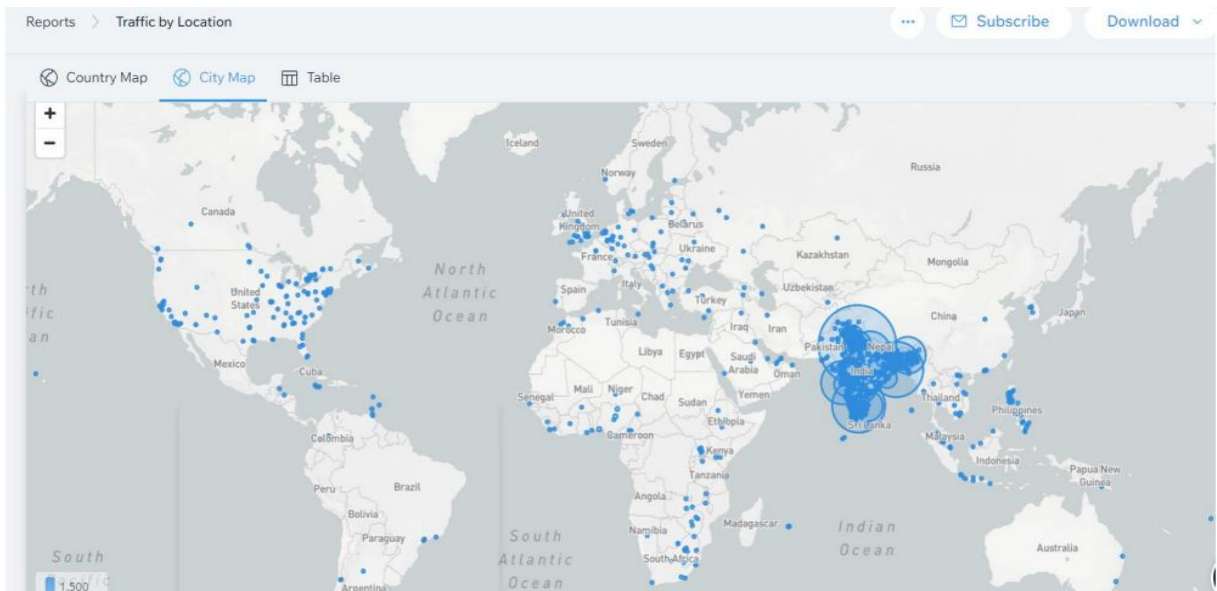


3. ABOUT THE LAW GURUKUL

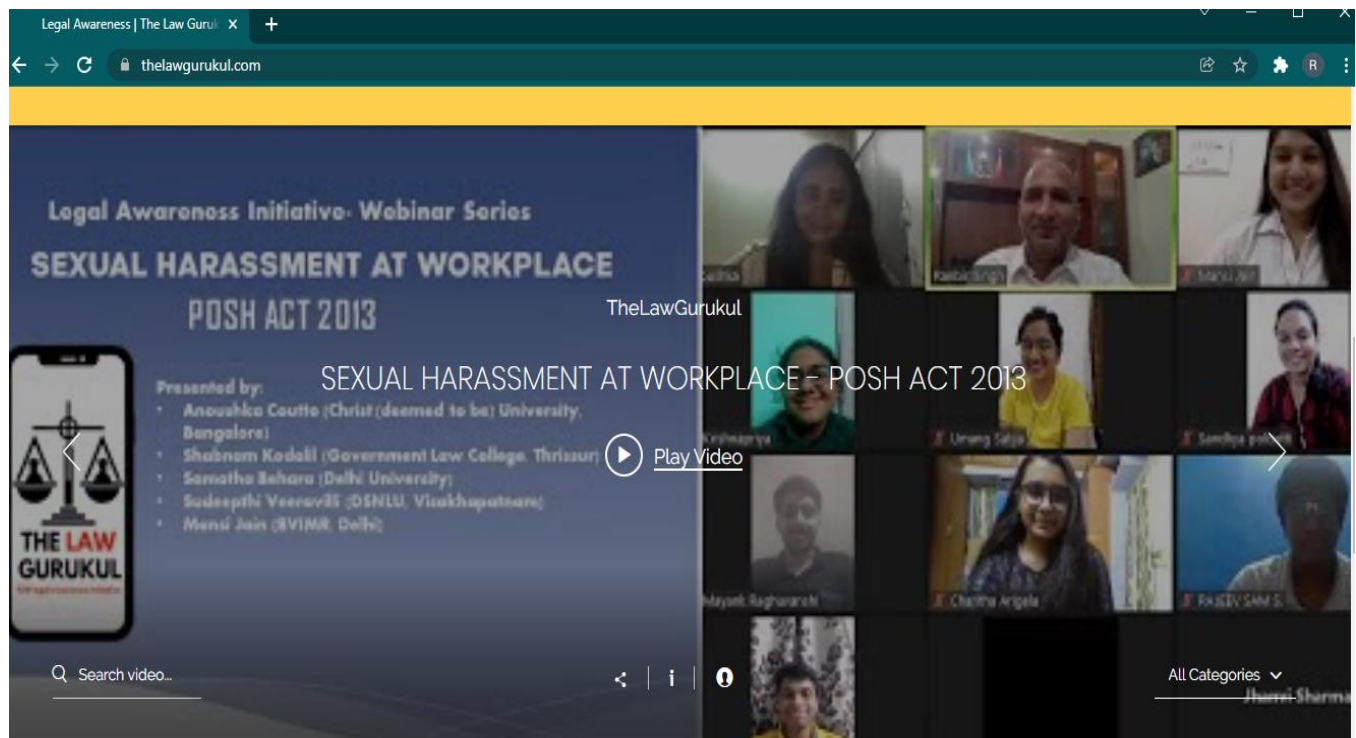
